Draft minutes of the Planning Committee meeting held at the Henstridge Village Hall Lounge on Monday 23<sup>rd</sup> August 2010.

## Present

**There were no members of the public in attendance.**

### 1. Apologies and to approve reasons for apology as seen fit.

Apologies had been received from Mr Fitch and the reasons given to the Council. Apologies had additionally been e-mailed by Ms Rowland but these were not received prior to the meeting and therefore were not reported.

**RESOLVED:** It was proposed and agreed to approve the reported reasons for apology as provided.

Mrs Oswick and Mr Stobart declared personal and prejudicial interests in items 9 and 10.

### 3. To approve as a correct record the minutes of the previous meetings held on 09.08.10 (Any amendments necessary to be received on the night).

**RESOLVED:** The minutes of the meeting were approved.

The plans were discussed at some length particularly in respect of the parking provision and the access into the development. Concerns were raised over the density of the parking. It was pointed out that there are letters of objection on the website supporting this concern and also raised issue over the lack of open space. It was felt that the access way should be completed prior to the commencement of the works as there are already residents present.

**RESOLVED:** It was proposed and agreed to recommend refusal of the application due to the fact that it is felt that the parking is inadequate for the density of the development. It is requested that any future application provides appropriate parking density and additionally would be subject to a condition requiring that the necessary access works are completed prior to the commencement of the building works.

Prior to leaving the meeting Mr Stobart expressed concern over the length of time that the matter has been going on and that this needs to be resolved. The feeling of the village hall committee currently is that the focus needs to be put on improving the existing hall.

Mr Stobart and Mrs Oswick left the meeting.

## **9. To receive an update from Mr Jarvis regarding the submission of additional information to the Planning Department regarding the Planning Application for Henstridge VHMC and agree any actions arising from this.**

## **10. Proposal that the Council writes to SSDC expressing disappointment over the handling of the planning applications with regard to the village hall and requesting that as this has never been validated, that the Council's funds are returned to them and that these are then reassigned to the fund for the provision and maintenance of the community building.**

While it was felt pointless that the District Council continues to hold Parish Council funds when no application has been validated, and there was an awareness that the likelihood of local donations towards provision of a hall in the current financial climate was slim, it was also felt that there was a possibility that wider funding possibilities could be pursued and that if the

planning application was not moved forward then this may prevent success in any kind of grant application.

**RESOLVED:** An amendment was put forward to the start of Ms Rowland's proposal that *"as funding could be dependent on planning permission being granted, that if by the first September planning meeting we have provided all of the documentation required by the 24<sup>th</sup> May letter to SSDC, if this has not then been validated by the second planning meeting that the Council...."*

The amendment to the proposal was voted on and approved. The amended proposal was voted on and approved. It was agreed to defer item 9 as it remained relevant following the amendment to item 10.

Mr Stobart and Mrs Oswick returned to the meeting.
